



2012 NORTHERN LIGHTS LINE WORKER OR VOCATIONAL SCHOLARSHIP GUIDELINES

- The Northern Lights Line Worker or Vocational Scholarship is for any scholarship applicant who may be attending a vocational college or line worker college.
- **The scholarship applicant or their parent/guardian must be a member of Northern Lights, Inc. Cooperative to qualify for the scholarship.**
- The applicants must submit a completed application form, which is available from Northern Lights. The applicants must also detail their goals in a personal statement. Two (2) character reference letters are required to be submitted with the application.
- All applications must be submitted to Northern Lights by mail to PO Box 269, Sagle Idaho, 83860 and postmarked no later than **April 6, 2012**.
- The Northern Lights Scholarship Committee will select the scholarship winners. The winners will be notified by **April 18, 2012**.
- Selection of scholarship recipients will be based as follows:
 - **Personal Statement**
 - **Financial need**
- The winners will be announced at the Northern Lights' 77th Annual Meeting on May 5, 2012 at Sagle School. A scholarship certificate announcing the award will be presented to each of the winners in time for recognition during graduation ceremonies (if applicable).
- Scholarship funds will not be dispersed until Northern Lights receives proof of enrollment in the school. Once proof of enrollment is received, the funds will be sent directly to the school in the student's name during the fall semester. Scholarships must be claimed by December 31, 2012, or the money will be forfeited.
- Northern Lights, Inc. employees, directors and their families are not eligible, (with the exception of line worker college).
